



MEMORANDUM OF UNDERSTANDING

Sister agreement

PRAHO! project, z. s.

registered in Korunní 2569/108, Praha 10, 101 00, Prague, Czech Republic
(hereinafter "PRAHO!")

and

STOCKHOLM! project, ideell förening

registered in Schlytersvägen 65A 12649, Stockholm, Sweden
(hereinafter "STOCKHOLM!")

(jointly referred to as the "Parties")

Article I: Introduction

1. The Parties confirm that they are independent non-profit organizations sharing a common mission in the fields of participatory and inclusive art, civic engagement, and work in public space.
2. This Memorandum establishes the framework of their sister relationship, based on equality, mutual support, and respect for the legal and cultural contexts of both countries.

Article II: Purpose of Cooperation

1. The aim of this Memorandum is to formalize the sister relationship between PRAHO! and STOCKHOLM!, set out the fundamental principles of cooperation, and ensure its continuity.
2. The cooperation shall include, in particular:
 - a. joint projects and grant applications,
 - b. exchange of know-how, methodologies, and educational outputs,
 - c. mutual support in fundraising, communication, and PR,
 - d. collaboration within international networks and partnerships.

Article III: Forms of Cooperation

1. The Parties shall regularly participate in Annual General Meetings (AGMs), held at least once a year in each organization.



2. During these meetings the Parties shall:
 - a. evaluate the activities of the past year,
 - b. review and update strategies,
 - c. propose and approve changes to statutes and internal regulations, reflecting the current status and future development.
3. Cooperation may take the form of:
 - a. joint implementation of artistic and educational activities,
 - b. sharing of human and financial resources,
 - i. Any sharing of financial resources shall always be subject to separate written agreements related to specific projects, in order to clearly define financial responsibilities and obligations of both Parties.
 - c. short-term and long-term residencies and exchanges,
 - d. representation of the sister organization when needed.
 - i. Representation of the sister organization shall only be possible with the prior consent of that organization, ensuring that no Party acts on behalf of the other without explicit authorization.
4. The cooperation is grounded in shared values of inclusivity, equality, participation, transparency, and sustainability.

Article IV: Rights and Obligations

1. Each Party retains its legal, financial, and organizational independence.
2. The Parties commit to transparent communication and to sharing relevant information concerning projects, funding, and organizational developments.
3. Each Party has the right to propose new forms of cooperation and the duty to contribute actively to the development of the relationship.
4. For joint grants or projects, detailed rights and obligations shall be specified in separate project agreements.
5. In the case of jointly developed intellectual property, including but not limited to methodologies, educational materials, and artistic works, the rights and responsibilities related to such intellectual property shall be defined in separate project agreements, in compliance with the applicable laws of both countries.

Article V: Duration and Termination

1. This Memorandum is concluded for an indefinite period.
2. Either Party may terminate this Memorandum with six (6) months' written notice to the other Party.
3. Termination does not affect the validity or completion of ongoing projects, unless otherwise agreed by the Parties.



Article VI: Legal Framework

1. Each Party is governed by the legal system of its country of registration: PRAHO! project by the laws of the Czech Republic, and STOCKHOLM! project by the laws of the Kingdom of Sweden.
2. This Memorandum does not replace the statutes or any other legally binding documents of either organization.

Article VII: Final Provisions

1. This Memorandum is not a legally binding contract of cooperation but a framework and good-faith commitment, reviewed and updated regularly by the Parties.
2. Any disputes or disagreements shall be resolved primarily through dialogue and amicable settlement.
3. This Memorandum enters into effect on the date of signature by both Parties.
